This is in further reply to your referral on May 7, 1963 of a letter from Mrs. Juanita Myers Williams of Anadarko, Oklahoma regarding medical services at the Anadarko clinic.

The Oklahoma Indian Health Area Director has advised us that Mrs. Williams' husband is a non-Indian from whom she stated in 1962 she was being divorced. Mrs. Williams was advised that in the event she was divorced from her husband she would become the head of her family and would then be in a high enough priority to receive medical services through the Indian health program.

Through her failure to provide the Public Health Service with documentary proof of her divorce, Mrs. Williams was denied medical care services, since she has other resources available to her as the wife of a non-Indian citizen.

I am writing to you concerning the Indian Clinic. here in Anadarko, Oklahoma. I have been going to this Clinic until recently one of the employees, a Mrs. Ballard, R.N., told me not to come back. She told me "not to come crying on my shoulders if your kid gets sick, because we won't treat him" Dr. Saylor, the Medical officer in charge of the Lawton PHS Indian Hospital, told me it was alright if I used the services both here and at Lawton, since my husband deserted me, and I didn't have a job or any money. Mrs. Ballard told me that if I got a divorce and could prove it, they would then accept me, and my child.

Since the Indian Bureau transferred the Medical care for Indians to Public Health, a lot of Indians have suffered and some do not receive any medical care at all.

We hope our Senators and Representaatives will look into the matter. In the meantime I will try to write to some of our Oklahoma Represenatatives in Washington.
