However, since an atmosphere of settlement still seemed to prevail, our Regional Solicitor, Tulsa, Oklahoma, was authorized to assist the interested parties with such further settlement arrangements as they cared to make.

At this time, there is no indication that the parties have concluded their negotiations. However, a copy of this letter is being sent to the Regional Solicitor, who may be able to give us some information regarding any developments in this matter. If so, we shall be pleased to pass this information on to you.
