WHEREAS, our review of the President's Budget for fiscal year 1964 indicates a Program Activities budget of \$58,985,000 for the

Division of Indian Health, representing a gross increase of \$2,402,000 over fiscal year 1963 for the same activities; however, over one-half of the increase must be utilized for mandatory pay increases and other costs, and

WHEREAS, the Surgeon General's Advisory Committee on Indian
Health for the past several years has recommended annual increments
of 5 million dollars for the Division of Indian Health's Program
Activities to allow for an orderly growth of the curative and preventive phases of the program.

NOW, THEREFORE BE IT RESOLVED that the Congress of the United States be, and it is hereby memorialized to support the Division of Indian Health's fiscal year 1964 request to the extent that the net increase will reflect an increment of 5 million dollars for Program Activities.
