Appointment of the Honorable Earl Welch, Justice of the Supreme Court of Oklahoma, to the Surgeon General's Advisory Committee on Indian Health was announced today by the Public Health Service. The appointment is for a four year term ending in 1967.

Justice Welch has served on the Oklahoma Supreme Court for 30 years, frequently as Chief Justice, has spent 15 years in private practice of law and six as a District Judge in Oklahoma. He is a member of the Chickasaw Indian Tribe and represents the third of four generations of a family in the legal profession. Both his grandfather and father practiced law in Indian Territory and after Statehood.

He was the first president of the Inter-tribal Council of the Five
Civilized Tribes of Oklahoma and again served in that capacity in 1961-62.
He also served on the Chickasaw Tribe's Governor's Advisory Council
continuously from 1939 until the recent death of Governor Floyd
Maytubby, whom he succeeds in the Surgeon General's Committee post.

Born near Wister in Southeastern Oklahoma when it was Indian
Territory, Justice Welch's home town is Antlers, where he was one of
the city's early mayors. He attended Harley Institute, an Indian boarding
school near Tishomingo, Oklahoma; Hargrove College at Ardmore, and
received his law degree from the University of Oklahoma. He was admitted
to the Oklahoma bar in 1911 and entered practice in Antlers.

Justice Welch's appointment completes the complement of the ninemember committee which advises the Public Health Service on its
activities to improve and expand medical care and health services for
American Indians and Alaska Natives.
