I have done everything I could to get these heirship claims expedited and have written in behalf of literally hundreds of claimants who were having difficulty finding out information on their claims, etc. You may be assured that I shall continue to do all I can to help get them settled as quickly as possible.

The Indian Office has advised me that a per capita payment will be made of the leased district award and the treaty funds. It is their plan to combine these two and make one per capita payment. The money for the leased district award has been appropriated, but the Congress has not yet appropriated money for the commutation bill.
