During the period, April 12-15, 1967, certain members of the Division Headquarters Office, the Indian Health Area Office at Oklahoma City, and I will meet with the various Indian beneficiaries in Oklahoma to review the Indian health program in that Area.

At these meetings we hope to obtain the Indian people's suggestions and recommendations on ways in which to improve health services in their particular service units and to announce certain Division program and policy changes with regard to eligibility for services. It is also planned to introduce the newly-appointed Indian Health Area Director, Dr. Jack Robertson, to the Oklahoma Indian beneficiaries.

We would be very pleased if you or a representative of your office could attend these meetings and participate in the discussions relative to the Indian health program in the Oklahoma Area.

Following is a list of meetings scheduled during April 1967:

- 1. April 12, 1967, 9:00 A. M., Talihina, Oklahoma. Quarterly meeting of the Inter-Tribal Council of the Five Civilized Tribes--Cherokee, Choctaw, Chickasaw, Creek and Seminole.
- 2. April 13, 1967, 7:30 P. M., Public Health Service Indian Hospital, Pawnee, Oklahoma. Pawnee, Ponca, Otoe-Missouri, Osage, Kaw, and Tonkawa Tribes.
- 3. April 14, 1967, 2:00 P. M., Concho Indian School, Concho, Oklahoma. Cheyenne and Arapaho Tribes.
- 4. April 15, 1967, 2:00 P. M., Public Health Service Indian Health Center, Shawnee, Oklahoma. Absentee-Shawnee, Sac and Fox, Potawatomi, Iowa, and Kickapoo Tribes. Indian people living in and around Oklahoma City will be invited to this meeting.

- 5. We have established a meeting on April 16 at Miami, Oklahoma, with the Indian Tribes in Ottawa County. These tribes include Delaware, Eastern Shawnee, Miami, Modoc, Quapaw, Seneca, Cayuga, and Wyandotte.
- 6. Another meeting planned after the Lawton Hospital dedication on April 22 will include the Kiowa, Comanche, Apache, Caddo, Wichita, and Delaware Tribes.

May we hear from you as soon as conveniently possible, as we would appreciate having the benefit of your ideas relative to the health program for Indians in the Oklahoma Area.
