Thank you very much for sending me a copy of your March 26 letter to Dr. E. S. Rabeau in which you strongly recommended Mr. John Spaan for the Executive Officer Position in the Oklahoma City Area Office of the Public Health Service's Indian Health Division.

As you may know, we recommended Mr. Spaan for this appointment and relayed other recommendations which came to us. We have urged that the person chosen to fill this important post be a well-qualified person, preferably an Oklahoman, who is familiar with, understands and is sympathetic with Oklahoma Indians and their problems.

Although an assignment had been made prior to our recommendations, I have been advised by Dr. Rabeau that a vacancy announcement for the Executive Officer position has been reissued. Dr. Rabeau has assured me that it is the desire of the Division of Indian Health to fill this vacancy with an individual who is thoroughly familiar with the needs of the Oklahoma Indian and who has a deep interest in the Indian Health program.

Again, thank you for your letter. I am pleased to have your thoughts and recommendation on this important matter.


