Dear Mr. Wilson:

I have been advised through Carl Albert's office that you are assisting in the review of Mr. John Spaan's application for the Executive Officer position in the Oklahoma City Indian Health Area Office.

It may be important to the President to know that Mr. Spaan is a civil service employee who feels that his government position in no way retracts from his responsibilities as a citizen in the political affairs of the country. Accordingly he and his wife, within the limits of the laws thereof, partake vigorously in the political affairs of the nation.

I'm sure the President already knows of the efforts this man expended in his behalf under the leadership of Mr. Kerr during the convention campaign of 1960. Mr. Spaan is no newcomer to the L.B.J. ranks, he's been a fan a long time!

There are people on Mr. Albert's staff who can verify this information. Mr. Breene Kerr, a son of our beloved Senator Kerr and a former schoolmate of Mr. Spaan, may also be able to provide verification. Marge Banner in Senator Harris' office may be able to help (she formerly worked for Senator Kerr).

I have heard of Mr. Spaan's protests of the criticism of the administration which have occurred in his own agency. He rises to speak against his superiors when he believes they are being disloyal to the President. He is heard because his support is deep-rooted and from the heart!

However, it occurs to me this may not endear him to some civil service management who may not share this administration loyalty.

I am enclosing a copy of Mr. Spaan's application letter. It is my belief it contains a lot of Lyndon B. Johnson philosophy.
