Dear Governor Overton:

Thank you very much for your letter of February 18 in which you were joined by other prominent and respected Indian leaders of Oklahoma in urging that Mr. John Spaan be given consideration for the Executive Officer position in the Oklahoma City Area Office of the Public Health Service's Indian Health Division.

We have also continued to strongly recommend Mr. Spaan for this position not only to Dr. Rabeau but also to Secretary Gardner, the Surgeon General, The Civil Service Commission and the White House. We are sending Dr. Rabeau a copy of your letter as a further indication of the widespread support Mr. Spaan has for this position. We have insisted that the Inter-Tribal Council Resolution adopted at the January meeting in Hartshorne be followed in this important matter and "that the Executive Officer be preferably an Oklahoman, who is qualified for the position, who is sympathetic with the Oklahoma Indian and who has an understanding of the Indian problems."

We will continue to do our best to carry out the wishes of our fine Indian friends in Oklahoma.

Dear Mr. Albert:

We know what motivates John Spaan. In order to remove any questions from others' minds, we have asked if he would accept the position at his present grade and pay. John Spaan eagerly accepted!

So now, we ask you: Who gets the job? Dr. Rabeau's man? The man a handful of bureaucrats want? Or a man the people, through their elected representatives, continue to insist is better for the job?

Again, the Indian people look to our Congressmen as the only hope to achieve the future America desires. Get tough with them! Tell them what you want for the Indian segment of your constitutency. Show them that we have a champion who can get things done for us. We still have faith in the influence you can wield, and we are going to count on you until it is proven that we cannot.
