Schwabe Member of Congress Hunt Building Tulsa, Oklahoma Dear Mr. Schwabe: I am glad to have your letter of July 16th in reply to one I wrote you on May 23rd giving you my views on H. R. 2536, the Bulwinkle Bill, and suggesting to you that it would be of interest to your constituents in the State of Oklahoma and the country at large to render your influence to bring about an early passage of this measure. Your views are quite sound and it is encouraging to know that we have a representative in Congress, from this District, who will, to the best of his ability, analyze and carefully digest any bill which he votes for or against. The large number of bills presented in the House makes it impossible for anyone to determine with any great degree of certainty the effects of the legislation proposed. That is why I took the liberty of writing you about the Bulwinkle Bill, because I felt that my experience in the transportation field qualified me to express an opinion about it. The Bulwinkle Bill, as you no doubt know, is a result of the anti-trust suit filed by the Department of Justice against the railroads and some of their principle officers alleging violation of the Sherman Anti-Trust Law. This action was taken by the Department of Justice notwithstanding the fact that the railroads, under the Interstate Commerce Act, are regulated by the Interstate Commerce Commission in the making and filing of freight rates. I think the filing of the suit against the railroads was ill-advised on the part of the Department of Justice, but then, in my opinion, a great many things that have been done by the Attorney-General's office in the last few years were improper and inimical to the public welfare. I do hope it will be possible for me to see you some time while you are in Oklahoma during the Congressional recess and I anticipate that possibility with real pleasure.
