RESOLUTION

WHEREAS, this Post has heretofore gone on record as urging quick, favorable action on Tulsa's application for an additional three hundred housing units to be furnished by the Federal Public Housing Authority; and

WHEREAS, in reply to our telegram to the Federal Public Housing Authority, we have been advised by the Regional Project Advisor of the Federal Housing Authority that the said agency would hold Tulsa's application for an additional three hundred emergency housing units until additional funds were made available, and

WHEREAS, it appears in the public press that the Congress of the U. S. has passed an Act appropriating millions of dollars to the FPHA for the purpose of furnishing emergency housing units to homeless veterans through their municipalities, and it appears that this act will be approved by the President, so that the money will be evailable to the FPHA; and

WHEREAS, it appears that on March 11, 1946, the Army made available to the FPHA more than 30,000 prefabricated buildings, in addition to the thousands of buildings and housing units already under the control of FPHA.

BE IT RESOLVED by Tulsa Post No. 577, Veterans of Foreign Wars, that the Federal Public Housing Authority again be urged to give quick and favorable consideration to the City of Tulsa's application for an additional three hundred Housing units for homeless Tulsa veterans in the light of the bulti-millions of dollars made available for this purpose by the Congress recently.

BE IT FURTHER RESOLVED that a copy of this resolution be forwarded to the Fort Worth, Texas office of the Federal Public Housing Authority and to the City of Tulsa, Oklahoma.
