Mr. Bell, Surplus Property Board stated that the Board is now in process of classifying ordnance plants, hospitals, etc to Federal Works Agency, industries and industrial project to RFC, cleared land, safety areas etc. to Agriculture, etc.

Stated that on Sept 20th he sent authorization to Mr. Fred E. Berquist, Deputy Director, Surplus Property Division of the Reconstruction Finance Corporation to proceed with preliminary negotiations, even though the properties involved might later have to be reclassified to other agencies. Said no reason why RFC cannot proceed at once with preliminary negotiations for sales, etc.

Called Mr. Fuller, who was out of town. Was referred to Mr. Nigel H. Bell, in charge of disposal of plants, Extension 6812, of the Industrial Real Property Division, and Mr. Donald McCormick, Extension 3451, Chief of that Division.

Mr. Bell stated that this whole thing has been sent to RFC, with authorization for the to proceed with interim negotiations for disposal or lease, pending receipt of formal papers from the War Dept. Stated he will be on the Hill tomorrow morning and would like to advise with the Congressman as to how to proceed with RFC.

You, of course, already have the information about the "demountable" houses in an earlier letter from me on this subject. I enclose herewith letter from one of my constituents, Mr. W. P. Phillips, and carbon copy of my letter to him in reply, which I think will be sufficiently explanatory.

Some days ago I wrote one of you, I think Mrs. Warren, in reference to the residence properties, telling her that I had a constituent who desired to purchase approximately twenty of the cottages in the Addition to Pryor. This is a different proposition, but does apply, so far as the residences are concerned, to their sale. I asked one of you in that former letter to try to determine who or which bureau has the authority to dispose of those residences.

Now I am interested in your finding out what the War Surplus Board or bureau, or whatever designation it carries, has done in connection with the dormitories and other buildings and other buildings at the Ordnance plant. There are some sixty-five of these large three-story frame dormitories in which there is a vast amount of materials that can be used by so many people in that vicinity or within forty or fifty miles of the plant which lies between Pryor and Chouteau. I recall distinctly having talked to a Mr. Pond in the office of the U.S. Engineers. I wish you would contact him and see whether or not the Ordnance Works, land and improvements, have been declared surplus property. If they have, then I am anxious to know just who is in charge and to whom I should appeal to make this material available for my constituents who need it so badly and with whom it can be put to such good use.

Please attend to this at your early convenience and inform me.

In the first place, I want to thank you for the suggestion. It is very appropriate and I am transmitting it to the proper authority with the request that due consideration be given the same. I have been working along the line of using the material in the dormitories and other buildings, so far as it may be salvaged, for the use of our people in the construction of houses, barns and other improvements on their places in the smaller towns and cities, as well as on the farms in that area. This is the same idea you have in mind, except for the fact that I think the disposition of the houses, the residence properties, which were built on the Addition to Pryor, and separated several miles from the Ordnance Works property, will be handled by a different organization, or bureau. However, the same purpose can be served in each instance and by each bureau.
