

Dear Sir:

We the members of the Tulsa Rental Property Owners Association respectfully ask why, in the face of rising cost of material and maintenence, that there has been no consideration given to our problems. In all your statements as to the benefits of price control and your control of inflation we Landlords who have suffered losses and a very dangerous depreciation in our investments have found no ray of hope for relief.

We are an important part of the American economy and the large majority of property owners are good honest citizens, but we have been censored and painted as a group of racketeers trying to gouge an unfair profit because of the shortage of housing.

If there was some relief for us and a chance of a decent profit and the control of our property returned to us so that we could evict undersirable tenants, there would be more houses opened up and more apartments available and over night the housing shortage would be eased considerably.

So again we ask why are we being discriminated against and close, hoping for an answer soon.
