Dear Friend:

I am just in receipt of your letter enclosing signed copy of resolution adopted by your Council on February 25, 1946 at Miami, Oklahoma, approving H. R. 1497, referred to as the Indian Claims Commission Bill.

It is gratifying to note that you have given this matter thorough consideration, and I am especially pleased to have your Resolution before me. I might say for your information that practically all of the leading Indians of Oklahoma who have given this matter serious thought and who are not promoting Indian Claims, so far as they have written or talked to me seem to favor this legislation.

The bill is the result of long and diligent study on the part of the Committee. Originally, when this Congress first convened in January, 1945, a bill was introduced by a Democratic Member of the House Committee on Indian Affairs and another in almost identical language was introduced by a Republican Member of the same Committee. The Committee has worked harmoniously and has attempted to use the best available information from our most intelligent Indiana who have the interests of the Indians and prospective claimants at heart.

Hence, I repeat that I appreciate very much your letter and the signed copy of the Resolution of your Council approving this measure. I think this legislation is designed to serve the purpose better than any other measure or idea that has been suggested.
