Dear Mr. Schwabe:

I have learned through the newspapers and over the radio that the Labor Management Conference at Washington has developed into a complete flop due to the bullheaded stand taken by Labor Leaders.

I also note that President Trueman has called for some kind of Labor Legislation to curb some of the many strikes that are demoralizing the business of this country.

Of course Trueman only called for this Legislation to appease the public, but if our Congress and Senate does their duty to the public and even to the Union working man themselves they will repeal the ridiculous Smith-Connelly anti-strike law and enact something in its place that is effective.

Of course anyone with ordinary intelligence knew that law was really no law at all and then what little effect it might have had if properly administered was killed by President Roosevelt with the assistance and advice of Biddle.

I would like to suggest that on any Legislation that you do try to pass that you keep out of the word anti-strike as that will make it appear that you are trying to take away from the Unions the right to strike at all.

The fact of the matter is I think Unions will always have the right to strike but the most vicious part of a strike is the picketing and that should be eliminated entirely as it is nothing more or less then mob rule by violence.

It is always referred to as peaceful picketing but in all my experience with handling labor and noting strikes and their effect I have never known of any peaceful picketing.
