I am pleased to acknowledge receipt of yours of the 17th instant relative to the so-called May labor conscription bill, which passed the House sometime ago. I note that your Chamber went on record as favoring the enactment of this bill into law.

I voted against the May Bill, and believe my position was correct. My aversion to some of the iniquities of the bill and its imperfections, are set forth in a speech of mine in the Congressional Record, copy of which I am pleased to enclose herewith.

I am favorable to the adoption of a law which will result in putting a lot of folks into the Army and essential industries who today seem to be dodging both; but I am not favorable to the enactment of any law that will destroy free enterprise and free labor in America. I am convinced that this is exactly what the May Bill will do if it becomes law, and do not believe the Senate will pass the May Bill in its present form.
