THE INTERNATIONAL BROTHERHOOD OF TEAMSTERS DESIRES TO RECORD ITS OPPOSITION TO HR 5262 NOW BEING CONSIDERED IN THE HOUSE. THIS BILL HAS NOT HAD THE BENEFIT OF PUBLIC HEARING AND THUS THE POSITION OF THE INTERNATIONAL BROTHERHOOD OF TEAMSTERS HAS NOT BEEN MADE KNOWN. THE BILL IS OF SUCH MAGNITUDE AND IMPORTANCE THAT IT IS INCONCEIVABLE THAT CONGRESS WILL ACT UPON IT WITHOUT ACCORDING LABOR AN OPPORTUNITY TO EXPRESS ITSELF AT COMMITTEE HEARINGS. IF ENACTED THIS BILL WILL IMPOSE DRASTIC CIVIL PENALTIES ON LABOR. IT WILL VIRTUALLY NULLIFY THE PROVISIONS OF THE NORRIS-LAGUARDIA ACT AND IT WILL SUBJECT WORKERS AND THEIR UNIONS TO COURT INJUNCTIONS FOR ALLEGED VIOLATIONS FOR WHICH THEY CAN BE PUNISHED BY FINE AND IMPRISONMENT. THE PROCEDURES FOR MEDIATION SET FORTH IN THE BILL REQUIRE DISCUSSION AND CONSIDERATION THE INTERNATIONAL BROTHERHOOD OF TEAMSTERS THEREFORE NOT ONLY PROTESTS THE PASSAGE OF THIS BILL WITHOUT COMMITTEE HEARINGS BUT IT EXPRESSES MOST VIGOROUSLY OPPOSITION TO THE BILL WHICH WILL DESTROY FUNDAMENTAL CONSTITUTIONAL RIGHTS OF THE WORKERS OF THIS NATION. THE EXECUTIVE BOARD OF THE INTERNATIONAL BROTHERHOOD OF TEAMSTERS IS NOW IN SESSION AND HAS UNANIMOUSLY ADOPTED THE FOREGOING STATEMENT ON BEHALF OF ITS 700,000 MEMBERS.

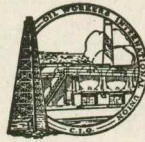
