

Dear George:

Was sure glad to know just how the cat got out of the bag. Personally, I think you are doing a swell job and I hope you will stand pat on the things that really concern the basic issues of Americanism. I also think the time has now come when labor laws should be passed that would protect the American public. The average man realizes that each and every group in the United States is entitled to justice and fairness, but when any group seeks to obtain a position that works a hardship on the general public, then it is time to call a halt, and do so in no uncertain terms.

I have been an employer the majority of my life, but I still am thoroughly in sympathy with any program that results in the proper equasion toward all groups. I think the time has actually come when we do not need to say "please" to organized labor, and has been here for some time, when it is necessary to put labor in its proper place and do so in no uncertain methods, and do it in any manner that is legal. I further believe that such a procedure will not follow until the present group of politicians and bureaucrats are dismissed entirely. In fact, Roosevelt did everything he could to encourage strikes, and in fact, he begged them to strike, urged them to strike, and paid them to strike, and it is not until new authority arrives on the scene will there be anyone up there with guts enough to say that organized labor is not going to dictate how every policy shall be governed concerning the United States.

but I do not believe that the O.P.A. has ever been run on a successful and sound basis, and in my judgment, it never will be run that way as long as the present group are in authority.
